On July 22, 2021, the Child Care eLicensing Project Investment Justification (PIJ) was approved without conditions by ADOA-ASET and ITAC. The project was approved for DHS to leverage the Agency's existing Salesforce eLicensing platform, via a system integrator, to develop the child care facility licensing feature sets. This initiative includes solution development, organizational change management, training, and formal transition to the ADHS Salesforce Maintenance and Operations. This will further integrate an additional licensing type within a single platform thereby further consolidating and modernizing the Division of Licensing's technology, improving the user experience, improving staff efficiencies, and improving the overall ease of audit of the data.

The original budget request of \$1,079,948.04 for the original PIJ submission of this project. The \$468,699.00 increase on this Change Request was planned to be submitted proactively in order to maintain transparency and ensure the project can be completed as intended.
