What is HEAplus?

HEAplus went live in October 2013

- Integrated Nutrition Assistance (SNAP) and Temporary Cash Assistance (TANF) screening in 2014
- Integrated Department of Child Safety (DCS) - 2016
- Integrated the Arizona Long Term Care (ALTCS) Program in Nov 2017

Effective integration with Federal and State partners

- 84,447 applications referred to Federal Marketplace (2020)
- 19,770 applications received from the Federal Marketplace (2020)
- 13 active real time connections for automated verifications

Sole system for <u>all</u> Medicaid eligibility determinations



What is an ALTCS transfer?

- The vast majority of ALTCS Customers have resources, like bank accounts, vehicles, insurance policies, and houses. As a result, many customers do not qualify for ALTCS due to being over the resource limit.
- When a customer gives away those resources, it is called a transfer of resources, and customers must verify where those resources went and if they received any compensation for the transferred resources.
- Transfers with uncompensated value are restricted from receiving long term care services (i.e., enrolled in a LTC plan, but for acute care only)



HEAplus ALTCS Transfer Issues

Problem Statement

- HEAplus needs add'l data collection screens, to allow for rebuttals, and new RFI blocks
- Manual work arounds and data fixes are required to ensure accurate determinations

Benefit of the System Change

- Manual tasks reduced 50% for applications with transfers
- Reduced appeals and service desk tickets
- Compliance with federal regs



Proposed Solution - Success

- Reduce transfer-related appeals by 90%
 - o 61 appeals received from 2/24/2020-2/24/2022

- Eliminate 90% transfer-related tickets




