Date/high-level overview of the approved original project investment justification (PIJ):

Business One Stop, is a single online location to help citizens & businesses plan, start, grow, move, & close businesses in Arizona through a secure, digital experience that does not require in-person interaction. The portal is being developed by the Department of Administration on behalf of the Department of Transportation, the Department of Revenue, the Secretary of State, the Arizona Corporation Commission and the Arizona Commerce Authority.

What initiated this change?:

• The current anticipated completion date for Phase 1 development is June 30, 2022. At this time, the Program anticipates all development work will be completed by the projected end date; however, in order to ensure we are delivering a stable and secure product, we would like to request an extension on the deployment timeline through August 3, 2022. This extension is 3-weeks beyond the original July 14, 2022 original end date. Additionally, as Phase 1 funds have been approved for use on maintenance and operational expense as well as Phase 2 planning, the Program requests that funds remain available through June 30, 2023.

Project Change Request Overview



What initiated this change?:

- The original timeline had the project starting in July 2021 and ending in July 2022; however, this timeline did not account for 2 yrs of funding; the milestones were set prior to requirements gathering sessions being completed; and, the timeline was overly optimistic.
- The Program struggled for several quarters to attain the staff need to bring the project into full production. A Program Manager and a Project Manager were not hired until FYQ3-Q4 2022.
- Competing priorities within agencies also resulted in some latency in API and UI development.
- Once requirements were documented within Information Architecture sessions, an agency critical to Business One Stop experienced significant struggles with outside development vendors. As a result of the lag in production, ADOA, the State Procurement Office and the Agency worked together to create a separate contract outlining commitment to Business One Stop. ADOA also supplemented the development work by contracting a developer to supplement the agency vendor.
- The Program struggled to overcome the cultural and programmatic differences among the various agencies.
