Completion of Epics Data Input Mapping, Reporting Part I, User Authentication & Role Management, and File Processing, Submission Window, Management UI, Fiscal Year Roll Over, and Configuration.
Development has been completed on Calculations, which was a four-month build.
We were granted an extension of time in which to utilize the Phase III appropriation until June 2024. The Phase III Plan is in final draft format. The Change Request and presentation to ITAC at the August meeting are in progress.
The revised ASK report was approved by JLBC, allowing us to utilize our upcoming budget appropriation for Phase III.
The IT team continues to meet deadlines throughout Phases I & II, complete this project under budget, and within the 10% threshold as proscribed by ITAC.
