In response to the Project Investment Justification (PIJ) for the "ADCRR Cameras Modernization Program - Mental Health Medical Areas" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to improve the security camera system overall including network quality, coverage and reliability.

The PIJ implies funding is available from the Base Budget in the amount of \$1,013,902.99 for the total estimated five-year life cycle cost for the project, which is shown below.
