Project Status



Description of Project

The Child Care Attendance Tracking system will provide an online attendance system that child care providers and
recipients can use to register a child's attendance at a child care facility. The system will then interface that data with
the Department's AZCCATS system to facilitate payment to the Child Care provider after verification by the
Department.

Why we are returning (only if it is not a regular update):

• The project is approaching the final stages of development and will enter User Acceptance Testing in the coming weeks.

Updates

- The project has encountered some delays from the original project timeline. The Department anticipates a schedule change request will be submitted to the Committee in either April or May once a final change in schedule is agreed upon with the Department and the vendor.
 - Delays have been encountered due to a statewide mailing vendor issue that required project resources to be redeployed to address the shut down of the agencies ability to print and mail forms to providers and print and mail checks for payments.
 - During the project, there have been high profile initiatives outside the agencies control that required project resources to be engaged. These include federal program initiatives that required system changes for new programs and to ensure funding provided under the American Rescue Plan Act (ARPA) was distributed timely and accurately to eligible programs/projects.
- The project remains on budget and the Department does not anticipate any changes in scope or cost as a result of the schedule delays.


