In response to the Project Investment Justification (PIJ) for the "Business One Stop" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to develop a portal that provides a single online location to help citizens and businesses plan, start, grow, move, and close in Arizona.

The PIJ implies funding is to be requested from APF Funds in the amount of \$7,758,828 for the total estimated five-year life cycle cost for the project, which is shown below.
