Project Introduction

Project Background:

- On May 13, 2021, Governor Doug Ducey and DES announced Arizona's Back to Work Program to help individuals transition from unemployment Insurance (UI) to a new job.
- One component of the Back to Work program is the Return to Work Bonus (RTWB) program.
- The program offers a one-time bonus of \$2,000 to certain eligible individuals who return to work by September 6, 2021, at a full-time job or \$1,000 for those working part-time.
- The bonus will be awarded to individuals who have stopped filing for unemployment insurance benefits and have worked for an employer for the required number of hours.
- The bonus will be offered on a first come, first serve basis. There are approximately 220,000 current Unemployment Insurance recipients who have the potential to qualify for the bonus.

Project Introduction

Problem Statement:

- A PIJ is needed to cover the implementation costs for the Return To Work Bonus (RTWB) Program.
- System requirements include a website application and a case management system that will capture the applications, proof of employment hours, the eligibility determination, case documentation, communication, and payment issuance.
- It is estimated that the RTWB Program software will be needed for 6 months. The website and case management system will need to be operational by July 10, 2021, and the program has an estimated end date of December 2021.

Solution

Procurement:

Several options were investigated as part of the research done to determine the best course of action for supporting the RTWB program.

A stand-alone RTWB website/system would be ideal for Arizona:

- Facilitates the RTWB program completely without needing to integrate with other external vendors.
- Can receive information from existing systems to aid in the eligibility process to determine those individuals who meet the RTWB criteria.
- Needs to be highly configurable to meet Arizona's needs.
- Allows for integration of the application, the eligibility process, customer communication and payment issuance from one source.
- Has a reduced timeline to implement the solution compared to building something from scratch.
- Accenture, LLP is the selected vendor.

Solution

Technology

The proposed solution facilitates the intake, eligibility determination and payment file output for the Return To Work Bonus Program.

- Easily configurable and integrated
- Confidential PII, FTI, and PHI data resides in a SOC 2 and SOC 3 certified environment
 Arizona DSA & SPO included
- Two system components: The Reach Solution is hosted in AWS with FEDramp Moderate controls. The ServiceNow solution is cloud-based and FEDramp compliant.
- Meets all Arizona Baseline Security Controls
- Potential future use for the possibility of extending the bonus program and/or Federal implementation of a similar program





Change Management

- The bonus program encourages UI
 recipients to seek/obtain employment
- Trained staff are knowledgeable and capable of addressing applicant's questions and completing the eligibility process
- Program implementation occurs timely
 and effectively

Measures of Success

- Fewer Unemployment Insurance recipients
- Eligible recipients receive the Return to Work Bonus
- Eligibility is determined accurately and bonus payments are paid timely.
- Program integrity is maintained with the use of fraud detection.

Requesting Approval For

The PIJ DE21022 DES Return to Work Bonus (RTWB) Program is for cost to include:

- Design and development of a web portal and application system
- Licensing and Maintenance costs
- AWS Data Center hosting costs

The duration of the RTWB solution

- The program is estimated at 7 months.
- The PIJ period includes 1 month of development and post go-live support through 8/31/21. Three additional months were added for payment of invoices. The PIJ End Date is 11/30/21.
