In an effort to comply with mandates of both the Governor's office and CMS to procure a system that is modular and reusable, AHCCCS proposed implementing a self-service web portal with back-end system integration to the Medicaid Management Information System (MMIS). This enables providers to have direct access to register, check on application status and update practice information independent of state staff involvement, streamlining the current process.
